SMO: Saint Lucia: OECS Pilot Program for Climate Resilience (P117330) Second Joint Mission & Technical Mission - May 9-12, 2011

This SMO has been cleared by Ellen Hamilton, Acting Sector Manager, LCSUW and
Christina Malmberg, Sector Leader, LCSSD.

- 1. A team comprising Justin Locke (Disaster Risk Management Consultant, LCSUW), Galen Evans (Junior Professional Associate, LCSUW), and Ariel Nunez (GFDRR Labs) will be traveling to Saint Lucia during the week of May 9-13, 2011 to participate in the Pilot Program for Climate Resilience (PPCR) Official Second Joint Mission and to conduct a technical mission. The PPCR Second Joint Mission will be held on May 10-11, 2011 at the Auberge Seraphine Hotel (May 10, 2011) and the Royal Saint Lucia Hotel (May 11, 2011).
- 2. As referenced in the attached Official Second Joint Mission Invitation and related agenda, the objectives of the mission are to: 1) Provide technical input towards the advancement of the draft Review Strategic Program for Climate Resilience (SPCR) and Investment Plan; 2) Provide recommendations for concessional financing for private individuals/firms through the International Finance Corporation (IFC); 3) Reach an agreement in principle on the components and priorities of the Investment Plan; and 4) Provide Guidance on the enabling environment and required mechanisms for effective and timely implementation during Phase 2 of the project.
- 3. **Justin Locke (May 10-11)** will lead mission discussions with PPCR focal points in Saint Lucia and participate in both days of the Joint Mission. Mr. Locke will also coordinate with Bank team members, PPCR focal points and relevant partners in Saint Lucia to finalize details for the mission agenda, and provide technical coordination with other project activities.
- 4. **Galen Evans (May 10-12)** will participate in mission discussions with PPCR focal points in Saint Lucia regarding data management activities within the national and regional PPCR process. He will also coordinate with PPCR data management focal points and national counter-parts on the deployment process of the GeoNode platform including finalizing the training process and data strategy.
- 5. **Ariel Nunez (May 10-12)** will provide technical support to the Government of Saint Lucia in deploying the GeoNode data management platform within the Governmental IT infrastructure.
- 6. Each team member will participate in different sessions of the Joint Mission according to their area of expertise. In addition, Mr. Evans and Mr. Nunez will hold meetings with and provide technical support to government counterparts on the installation and deployment of the GeoNode data management platform.

- 7. **Outputs:** Each team will member will prepare: 1) his contribution to the joint mission aidememoire while in the field; and 2) his technical contribution/review of the SPCR.
- 8. A Back-to-Office Report (BTOR) and a joint mission aide-memoire/joint mission report will be circulated upon return to Washington.
