We support the Japanese comments and the one from Spain regarding the role of EBRD. I would like however to add two more:

1- Regarding the "transfer of concessionality" to the final beneficiary of the loan, would it be possible to know how the concessionality is shared between the banks involved and the final beneficiary?

2- A guide is to be prepared on best practice regarding energy efficiency. It would be important there to share all the existing experience and to associate the other actors involved in Turkey in this regards.
